IN CONFORMITY to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships or Vessels," &c., passed the 18th February, 1793, and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern, and Northwestern Frontiers of the United States, and for other purposes," passed the 2d March, 1831, and the Acts of the 7th July, 1838, 29th July, 1850, 6th May, 1864, and 17th June, 1864.

James Van Buren of Buffalo, N.Y. having taken or subscribed the Oath required by the said Acts, and having sworn that he, together with J. Palm and David and Thomas H. Ryan of the same place, are

citizens of the United States, and sole owners of the Canal Boat or vessel called the A. Q. Lawrence of Buffalo, whereof James Van Buren is at present Master, and as he hath sworn that he is a citizen of the United States, and that the said Canal Boat or vessel, was built at Rochester, N.Y. in the year 1862 as appears by her last Enrollment at this Port, dated May 14, 1864, numbered 214. Now surrendered having changed said Enrollment.
