IN CONFORMITY to an Act of the Congress of the United States of America, entitled "An Act for Enrolling and Licensing Ships or Vessels," &c., passed the 18th February, 1793, and "An Act to Regulate the Foreign and Coasting Trade on the Northern, Northeastern, and Northwestern Frontiers of the United States, and for other purposes," passed the 2d March, 1831, and the Acts of the 7th July, 1838, 29th July, 1850, 6th May, 1864, and 17th June, 1864.

*A. W. Becker of Buffalo, N. Y.* having taken or subscribed the oath required by the said Acts, and having sworn that he, ~~together with~~ *is a*

citizen of the United States, and sole owner of the *Canal Boat* vessel called the *A. Ferguson*, of *Buffalo* whereof *he* is at present Master, and as he hath sworn that he is a citizen of the United States, and that the said *Canal Boat* vessel was built at *East Saginaw, Mich* in the year 1870 as appears by *her last Enrollment at the Port of Port Huron, Mich. dated Aug 21, 1871 & numbered 94.* And *said Enrollments.* (*now surrendered having changed Owner & District*)

having certified that the said *Canal Boat* or vessel has *One* deck and *two* masts, and that her length is *94* feet, her breadth *17* feet, her depth *7* feet, her height *10* feet; that she measures *100* tons and *52* hundredths, viz.:
