Edgar Haught of Buffalo N.Y. taken or subscribed the oath required by the said Acts, and having sworn that he, together with

is a citizen of the United States, and sole owner of the ~~Bunalboat~~ vessel called the *Frank Gilbert*, of Buffalo whereof *he* is at present Master, and as he hath sworn that he is a citizen of the United States, and that the said ~~Bunalboat~~ or vessel was built at Buffalo N.Y. in the year 1873 as appears by the certificate of Edgar Haught shipwright her builder.
