*Catharine E. Cole of Buffalo, N.Y.* having taken or subscribed the Oath required by the said Acts, and having sworn that she, together with *own and three fourth (3/4), and that Oliver E. Hubbard of the same place, own One fourth (1/4), and that they are*

citizen of the United States, and sole owner of the *Eng Propeller* vessel called the *J. C.
